FINANCIAL CONTRIBUTION TO THE CORPORATION DE DÉVELOPPEMENT ÉCONOMIQUE EST-OUEST, BLANC-SABLON REGION FOR THE YEAR 2026

WHEREAS the Corporation de développement économique Est-Ouest, Blanc-Sablon Region, receives an annual financial contribution of \$ 60,000 to support the operations of the Blanc-Sablon Recreation Center from the Municipality;

WHEREAS the Corporation de développement économique Est-Ouest, Blanc-Sablon region reiterates their request for the year 2026;

WHEREAS the Municipality of Blanc-Sablon wishes to maintain its support while ensuring sound management of taxpayers' money;

WHEREAS the Municipality granted an interest-free subsidy advance in the amount of sixty thousand dollars (\$ 60,000) to the Economic Development Corporation in 2025, and the repayment terms are for \$ 12,000.00 annually until 2030 inclusively;

CONSEQUENTLY, it is proposed by **Alexis Beaudoin**, seconded by **Johanne V. Beaudoin** and unanimously resolved to grant a financial contribution of \$ 48,000 to the Corporation de développement économique est-ouest, Blanc-Sablon region, to defray, in part, the operating costs of the recreation center and sports and leisure activities with conditions;

That the following conditions apply:

- a quarterly report from the Corporation showing the statement of revenues and expenses;
- financial statements produced within the time frame prescribed by the MAMH
- a number is obtained from Loto-Québec for fundraising;
- forward a copy of the pro forma budget for the year 2026;

THAT the sending of the monthly payments is conditional to the respect of the above mentioned expectations.

THAT the Municipality be informed of all projects involving capital expenditures.

DEPOSIT OF THE ANNUAL REPORT ON THE APPLICATION OF THE CONTRACTUAL MANAGEMENT 2025

In accordance with article 938.1.1.2 of the *Municipal Code of Quebec*, the general director submits to the Council the annual report on the application of the contractual management regulations.

FEDERAL GOVERNMENT PROJECT: REVIEW OF THE MANDATE OF CANADA POST CORPORATION

WHEREAS the federal government has announced a review of Canada Post's mandate, to take place from October 1, 2025, to March 31, 2026, as follows:

In theory, public consultations may be conducted to review the Canadian Postal Service Protocol (2009) and gauge the pulse of Canadians regarding their needs and use of the postal service. If a consultation were necessary, the objective would be to obtain the views of Canadians and stakeholders in order to redefine Canada Post's service-oriented vision, in a context where the postal industry landscape has changed, the needs of Canadians have evolved, and the volume of mail and letters has declined significantly to the point of undermining Canada Post's viability.

WHEREAS the current plan does not indicate that there will be public consultations or participation by all stakeholders, and whereas the process and terms of reference for the mandate review have not yet been announced;

WHEREAS the recent report of the Commission of Inquiry on Labor Relations recommended service cuts in the form of post office closures and the reactivation of the previous Conservative federal government's program to replace mailboxes with community mailboxes;

WHEREAS the government needs to know the municipalities' views on the most important issues, such as maintaining Canada Post as a public service, the importance of the moratorium on post office closures, improving the Canadian Postal Service Protocol, maintaining home delivery, parcel delivery, and daily delivery, creating a postal bank, greening Canada Post, adding electric vehicle charging stations, food delivery, improving delivery services in rural, remote, and Indigenous communities, and creating services to help people with reduced mobility and seniors remain in their homes as long as possible, thereby ensuring the retention of good jobs in communities and the financial independence of Canada Post;

CONSEQUENTLY, it is proposed by **Jeremy Griffin**, seconded by **Johanne V. Beaudoin**, and unanimously resolved:

THAT the Municipality of Blanc-Sablon write to the Minister of Government Transformation, Public Works, and Procurement, Joel Lightbound, to request that he postpone the review of Canada Post's mandate until such time as Canada Post's operations have stabilized, the impact of the stamp price increase has been felt, and parcel volumes truly reflect demand in this sector;

TO INCLUDE in its letter to Minister Lightbound that any review of Canada Post and the Canadian Postal Service Protocol be conducted in a transparent, public, and thorough manner, and include public hearings with the participation of all stakeholders in all regions of Canada;

TO submit a brief or participate in the hearings to provide its perspective as part of the Canada Post mandate review process.

ADOPTION OF BY-LAW 2025-R-003 AMENDING BY-LAW NUMBER 2003-R-003 CONCERNING THE REMUNERATION OF ELECTED MUNICIPAL OFFICIALS

WHEREAS the *Municipal Code of Québec* (RLRQ, chapter C-27.1) allows municipalities to determine the remuneration of their elected officials;

WHEREAS the municipal council deems it appropriate to amend by-law number 2003-R-003 in order to adjust the remuneration of municipal elected officials;

WHEREAS the project by-law in question was the subject of a notice of motion at the municipal council meeting on September 30th, 2025.

CONSEQUENTLY, it is proposed by **Dany Gaudreault**, seconded by **Alexis Beaudoin** and unanimously resolved to adopt the By-Law 2025-R-003 that decrees and orders as follows:

ARTICLE 1

The preamble is an integral part of the present by-law.

ARTICLE 2

The present by-law replaces the by-law 2003-R-003 and bears the title "By-Law Establishing the Remuneration of Elected Officials".

ARTICLE 3

The present by-law establishes the annual remuneration for the Mayor and each councillor of the Municipality for the following fiscal years.

ARTICLE 4

The Mayor's remuneration is set as follows:

- a) Basic annual remuneration: \$ 20,000.00;
- b) Annual expense allowance: \$ 10,000.00.

The annual base remuneration and expense allowance are paid in twelve (12) equal monthly installments.

The remuneration of councillors is set as follows:

Remuneration per municipal council meeting: \$ 150.00, i.e.:

Base salary per meeting: \$ 100.00;

Expense allowance per meeting: \$ 50.00;

For a basic annual remuneration of \$ 2,400.00 and an annual expense allowance of \$ 1,200.00;

The basic annual remuneration and annual expense allowance are paid in twelve (12) monthly installments.

The remuneration of each elected member will only be paid to the councillor if they attend the regular monthly council meeting, with each attendance entitling them to their basic annual remuneration.

However, if the absence is deemed justified the remuneration will be paid.

ARTICLE 5

An additional remuneration granted in favour of special mandates thereafter described and according to the modalities stated.

- a) Acting Mayor; \$ 25 per meeting during which he represents the Mayor. Maximum amount allocated per month \$ 50.
- b) Member of a board of directors or subcommittee (ex: planning advisory committee, leisure committee, daycare committee, etc. to which the elected member was mandated by a resolution of the council); \$ 25 per meeting of the board of directors or working session which he attended for a maximum of \$ 50 per month for each board of directors or working session per committee.

ARTICLE 6

If the Acting Mayor has to replace the Mayor for more than thirty days, the Acting Mayor will be entitled from the first day of replacement to the end, to an amount equal to the remuneration of the Mayor providing that the Acting Mayor assumes all the responsibilities of the Mayor.

ARTICLE 7

Each council member will receive in addition to his basic remuneration an expense allowance equal to half of his basic remuneration as decreed in Article 4.

ARTICLE 8

The remuneration decreed in Article 4 and 5 and also the expense allowance decreed in Article 7 will be paid to each elected member on monthly basis, the last day of each month.

ARTICLE 9

The present by-law will come into effect in accordance with the law.

CONSEQUENTLY, it is proposed by **Alexis Beaudoin**, seconded by **Johanne V. Beaudoin** and unanimously resolved:

THAT the Municipality of Blanc-Sablon add the Corporation de développement touristique et culturel du Canton de Brest as an additional insured to its applicable insurance policies;

THAT the Municipality will re-invoice the Corporation for its portion of the applicable insurance premiums;

THAT the General Manager be authorized to sign all necessary documents for the addition of the Corporation to the Municipality's insurance policies.

REQUEST FOR FINANCIAL ASSISTANCE FOR A CHRISTMAS SUPPER FOR SENIORS IN COLLABORATION WITH THE ORGANIZATION "LA TABLÉE DES CHEFS"
